
I, the student, understand that I HAVE to provide the following documentation at the time of testing in order to be eligible to take the DPS road test. If I do not bring all the necessary documentation or reach the age/ permit eligibility by the day of my test date, I will not receive a refund, I will be charged a \$30 reprocessing fee, but can be rescheduled at our earliest convenience. I also understand that if I cancel my appointment less than 24 hours from my appointment date and time I will also be charged a \$30 late cancellation fee, I will not receive a refund, but can be rescheduled at our earliest convenience. Please see **page 2** for a list of eligibility requirements and documentation. I understand that Patriot Driving Academy is prohibited from issuing a certificate of road test completion if the student has not met all the requirements for course completion.

I, the student, understand that Patriot Driving Academy is a 3rd party testing facility and that they will NOT be able to issue me a driver’s license. Patriot Driving Academy can only provide the DPS road test required to obtain a driver’s license. I, the student, understand that I will have to make an appointment with DPS in order to physically obtain my driver’s license.

I, the student, understand that Patriot Driving Academy has the right to reschedule my appointment at any time due to inclement weather, mechanical breakdown of our automobile, illness, or any other factor beyond its control. If Patriot Driving Academy needs to reschedule my appointment, they will do so as soon as they possibly can, or I may ask for a refund and a full refund will be provided to me.

**DPS TESTING REQUIREMENTS VEHICLE REQUIREMENTS. VEHICLE MUST:**

*If the vehicle brought to testing does not meet the requirements below, students may use our vehicle for testing which will be an additional \$15 charge. If the student does not wish to use our car and wants to reschedule we will charge a \$30 rescheduling fee.*

- Have a license plate on the front and rear of the vehicle
- Have valid insurance (DPS instructor will need a physically **PRINTED** copy of insurance)
- Be a SMOKE FREE/ Free of any ODD ODORS AND passenger side be free of ANY debris

**DPS TESTING REQUIREMENTS TEEN (AGES 16-17):**

*Legal guardian must be present during time of testing.*

- Students must be at least 16 years of age and have had a valid permit for 6 or more months. Please check the back of your permit and view the “must hold valid learner’s license to “DATE”.  
Students must have completed their entire driver's education requirements. Student must provide either:
  - DE Certificate labeled “FOR DRIVER’S LICENSE ONLY”. Obtained through a driving school.  
OR
  - PT Certificate labeled “FOR DRIVER’S LICENSE ONLY”. Obtained through a Parent Taught Program. + 14 hour driving log: <https://www.allstardriveredonline.com/forms/TexasDriveLogs.pdf>
  - Completed and printed “IMPACT TEXAS TEEN” Certificate. (Certificate MUST be dated within 90 days of testing). LINK FOR VIDEO: <https://impacttexasdrivers.dps.texas.gov/>
  - 30 hour Parent Log completed:

  - Verification of Enrollment Form from school. (MUST be dated within 30 days of testing). If a student has graduated before 18 years of age, we will need your original diploma.

**DPS TESTING REQUIREMENTS ADULT (18-19 USING TEEN CERTIFICATE DE-964):**

***DE-964 CERTIFICATE CANNOT BE USED IF 20 YEARS OLD +***

- Have a valid TX permit
- DE Certificate labeled “FOR DRIVER’S LICENSE ONLY”. Obtained through a driving school.  
OR
- PT Certificate labeled “FOR DRIVER’S LICENSE ONLY”. Obtained through a Parent Taught Program. + 14 hour driving log: <https://www.allstardriveredonline.com/forms/TexasDriveLogs.pdf>
- 30 hour Parent Log completed:

- Have a valid TX permit
- ADE-1317 Certificate (Completed the 6 hour adult course)
- Completed and printed “IMPACT TEXAS ADULT” Certificate. (Certificate MUST be dated within 90 days of testing) LINK FOR VIDEO: <https://impacttexasdrivers.dps.texas.gov/>

**DPS TESTING REQUIREMENTS ADULT (25+):**

- Have a valid TX permit
