This agreement constitutes the entire contract between the Academy and the student and no verbal assurances or promises not contained herein shall bind the Academy or student.

- Patriot Driving Academy does not provide a refund for the road test for any reason. The only exception is if the Academy needs to reschedule the appointment, then the Academy will offer to reschedule to the next soonest appointment available, or the student may ask for a refund and a full refund will be provided.
- The Academy has the right to reschedule the road test appointment at any time due to inclement weather, mechanical breakdown of our automobile, illness, or any other factor beyond its control.
- To be eligible to test with the Academy, the student must provide the documentation and meet the age/ permit requirements (listed on page 2). Failure to provide any of the correct documentation on the day of the test will result in the cancellation of the test and a \$30 late cancellation fee will be applied. The Academy can reschedule the appointment to the next available appointment after the cancellation fee is processed.
- Students must provide the Academy a 24-hour notice before their appointment if they need to reschedule. Appointments canceled less than 24 hours before the original date/ time will be charged a \$30 late cancellation fee.
- Students who reschedule their initial appointment can be rescheduled at our earliest convenience. The Academy will not reschedule your appointment more than 2 times after the initial appointment, otherwise the road test package becomes null and void.
- Your package becomes null and void and students will have to repurchase the road test package at the current price if you do not contact the Academy to reschedule your road test within 14 days after any scheduled road test date.
- Your package becomes null and void and students will have to repurchase the road test package at the current price if you have incurred any fees as stated above and do not pay this fee within 5 business days of obtainment.
- Students are provided with a Student Portal account upon registration with a username and password. Students may log into the Student Portal to cancel the road test, or cancel by email or contacting us by phone.
- The Academy is a 3rd party testing facility and CANNOT issue a driver's license. The Academy can only provide the Class C DPS road test required to obtain a driver's license. You have to make an appointment with DPS to physically obtain your driver's license.
- Please allow enough room in your vehicle (trunk or back seat) for our 3ft, plastic cones for parallel parking. The Academy is not responsible or liable for any damages caused by our cones.
- Patriot Driving Academy is not liable for any damages, accidents, or incidents that may occur to a person and/or their vehicle during an administered road test. The individual agrees to hold the Academy and road testing instructor harmless from any claims, damages, liabilities, or expenses arising out of or related to the road test conducted in any vehicle including the Academy's. The student who is testing retains full responsibility for the condition and maintenance of their vehicle, including ensuring it meets all necessary safety requirements for the road test.
- In the event that a student, parent, or legal guardian exhibits any kind of animosity, impolite, or threatening behavior toward the instructor or any staff member, the road test will be immediately cancelled, will not be rescheduled, and the student will be barred from Academy.
- Please note we only accommodate one appointment at a time in our office. Students will be asked to wait outside or in their vehicle until the instructor is ready for your appointment. The Academy typically administers back to back appointments and could be running behind for your appointment.
- Patriot Driving Academy is dedicated to assisting students with any questions or concerns. Students may contact our office prior to testing to ask any questions or clarification on what documentation is needed to test.

# Authorized DPS Checklist Requirement To Test With Patriot Driving Academy #C3486

## TESTING VEHICLE: *The following is required when using your own vehicle*

If the vehicle brought for testing doesn't meet the requirements, students can use our vehicle for an additional fee. Alternatively, if the student prefers to reschedule instead, a rescheduling fee will apply. *Fee to use our vehicle does not apply to our current/former students who have used our in-person services before.*

- Have a valid dealer plate or paper buyer's tags **MOUNTED** on the **front & rear** of vehicle
- Have valid physical **PRINTED** insurance card on vehicle
- Be SMOKE-FREE/ Free of any ODD ODORS AND THE passenger side be free of ANY debris
- Need space in the trunk or backseat for 3 ft plastic cones

## TEEN (16-17): *A legal guardian must be present at the appointment.*

- Be a **MINIMUM** of 16 years of age. Student's **cannot** test before 16th birthday
- Have had a **VALID** TX permit for 6 or more months. The 6-month date is located on the back of the permit. (Restriction B & F)
- 30-hour Parent Log: [30 Hour Log](#)
- "IMPACT TEXAS TEEN" Certificate. (MUST be dated within 90 days of testing). LINK: [Impact Video](#)
- Students must have completed their entire driver's education requirements. Students must provide:** DE-964 Certificate labeled: **"FOR DRIVER'S LICENSE ONLY"**.

If the certificate is check marked **"Driver Education School"**, students must provide credit for completion of classroom hours and 14 hours behind the wheel.

*This could result in the issuance of 2 separate certificates.*

**\*\*\*OR\*\*\***

If the certificate is check marked **"Parent Taught Course"**, only 1 certificate is issued.

*Unless the student transferred their classroom hours to a separate school for the 14 hours behind the wheel which could result in the issuance of 2 separate certificates.*

## ADULT (18-19): *Using teen DE/PT certificate (Cannot be used if 20+ years old)*

- Have a **VALID** TX permit (Restriction B)
- DE or PT Certificate labeled **"FOR DRIVER'S LICENSE ONLY"**. (See certificate details in above section).
- 30-hour Parent Log: [30 Hour Log](#)
- "IMPACT TEXAS ADULT" Certificate. (Certificate MUST be dated within 90 days of testing) LINK: [Impact Video](#)

## ADULT (18-24):

- Have a valid TX permit (Restriction B)
- ADE or ADEE Certificate (Completed the 6-hour adult course)
- "IMPACT TEXAS ADULT" Certificate. (Certificate MUST be dated within 90 days of testing) LINK: [Impact Video](#)

## ADULT (25+):

- Have a valid TX permit (Restriction B)
- "IMPACT TEXAS ADULT" Certificate. (Certificate MUST be dated within 90 days of testing) LINK: [Impact Video](#)
